

2026 Parent Payments

Dear Parent/Guardian,

Malvern Central School is looking forward to another great year of teaching and learning. We are writing to advise you of the school's voluntary financial contributions for 2026.

Schools provide students with free instruction to fulfil the standard curriculum requirements, and we want to assure you that all contributions are voluntary. However, we do need the support of families to ensure we can deliver the best possible learning outcomes for students.

For 2026, we are requesting:

- *Curriculum and Other Contributions: \$755 (comprising \$640 curriculum contribution plus \$115 for essential supplementary items)*

After providing families with a one-year holiday from the \$115 supplementary fee, we need to reinstate it for 2026 to cover the rising costs of digital devices, first aid and hygiene supplies, and STEM and wellbeing programs.

The School Council has worked hard to keep increases at an absolute minimum despite high inflation over recent years. In fact, our total curriculum contribution for 2025 was lower than in 2024, and we have maintained the core curriculum contribution at \$640 for 2026. We have only reinstated the supplementary fee to ensure we can continue providing essential resources and programs for our students.

In addition to curriculum contributions, families can choose to make tax-deductible donations to our Building Fund and/or Library Fund. Without continued contributions to these funds, projects such as landscaping of the Park St colourful playground and replacement of the turf at both campuses would not be possible. Parents can claim these donations as income tax deductions.

Being a Government School, Malvern Central receives funding from the Department of Education for basic education requirements, including staff salaries and operating costs. Your voluntary contributions go directly to our school to supplement this funding and enable us to provide enhanced learning opportunities.

- *Curriculum Contributions support items that directly improve student learning of the Victorian Curriculum, such as materials for science experiments and art, and online numeracy and literacy platforms*
- *Other Contributions support non-curriculum items including first aid supplies, hygiene products, wellbeing programs*

We invite you to read the attached document showing how voluntary fees are spent and the programs they support.

Over the years, your generous contributions have enabled us to provide high-quality education programs, extra professional development for teachers, as well as community planting and landscaping, fresh painting and air conditioner upgrades, amongst other things.

We understand that not everyone has the means to contribute the full requested amount. You can choose to pay the requested amount for each type of contribution, or you can nominate another amount that works for your family. The fee is set on the basis of the parents contributing, and without these contributions, the School will not be able to meet all of the planned expenditure.

Refunds

Parent requests for refunds are subject to the discretion of the school and made on a case-by-case basis. Refunds for nonattendance to event will be made if no cost is incurred and payment was above \$20. Refunds below this level need to be requested by the family.

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions
Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions
Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities
Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).

FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
